



ENVIRONMENTAL POLICY

IMCA S.p.A. has defined an environmental policy, in which are stated the objectives it has set aimed at improving its performance in order to mitigate the environmental impacts related to the activity of the Organization. This policy is disseminated to all levels of the organizational structure, providing for the involvement of all corporate functions whose activities have an influence on the environment, as well as to customers and the public through, training and website. I.M.C.A. S.p.A. processes 100% of Italian fresh tomatoes mainly from Central and Southern Italy, and most of the suppliers are certified according to the Protocol of Good Agricultural Practices and adherents to the Agricultural Quality Work Network, cultivating in accordance with the principles of integrated pest management while minimizing the use of pesticides, taking into account the protection and preservation of the environment and waste management. I.M.C.A. S.p.A. fulfill all applicable legal requirements relating to the upholding of the environment and other requirements that the organization subscribes to regarding its environmental aspects. On a voluntary basis, the organization has expanded a management system (ISO 14001 and EPD Environmental Product Declaration) which starting from the assessment of all environmental aspects, distinguished them from time to time on the basis of their impact and study the solution for mitigating their effects at each stage, seeking to prevent or reduce pollution and improve the working environment. The reduction of environmental impacts involves various factors such as the technological renewal of the processes, plants and equipment used, the differentiation of waste, the use of energy from renewable sources and the readiness to respond to any emergency situations.

In defining its environmental policy, the Organization shall consider the following:

- Identifies the mission, vision and essential values and beliefs of the Organization on the protection of the environment;
- Ensures compliance with all applicable environmental legislation in its production environment;
- Aims at continuous improvement, in addition to legal obligations, environmental performance and environmental management system of the Organization
- Performs in advance an assessment of the environmental impacts of any new activities or new products/processes;
- Quantification the environmental impacts of products during their life cycle;
- Involves employees, through information and appropriate training, in order to promote a sense of responsibility for compliance with the policy and its objectives and programs;
- Verifies, monitors and controls compliance with environmental policy and the definition of any corrective action, through an internal audit and review mechanism by the Single Administrator;
- Cooperates with public authorities to manage possible emergency situations in order to minimize accidental environmental impacts resulting from possible emergency situations;
- Provides Customers with the appropriate information, in order to respect the environment, on the handling, use and disposal of the Organization's products;
- Manages the products (packaging, transport, use and disposal) in order to reduce environmental impacts;
- Raises awareness and enforcement of environmental procedures of the suppliers.

IMCA SPA subscribes the commitment to support the fight against deforestation, land depletion and the exploitation of indigenous peoples through the following measures:

- Monitoring and risk assessment of suppliers affected by the EUDR regulation
- FSC (Forest Stewardship Council) certified suppliers
- Raising awareness of the use of recycled packaging
